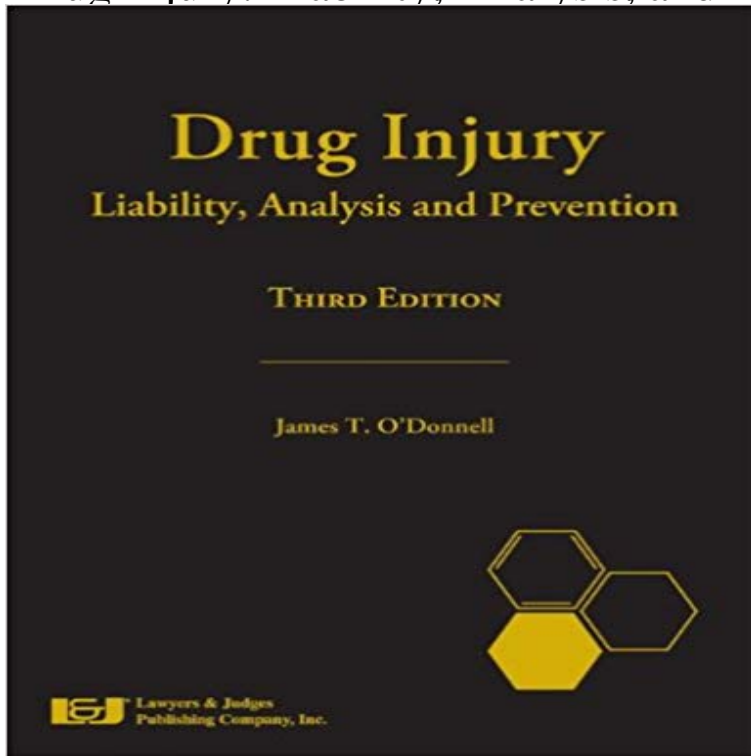


Drug Injury: Liability, Analysis, and Prevention, Third Edition
