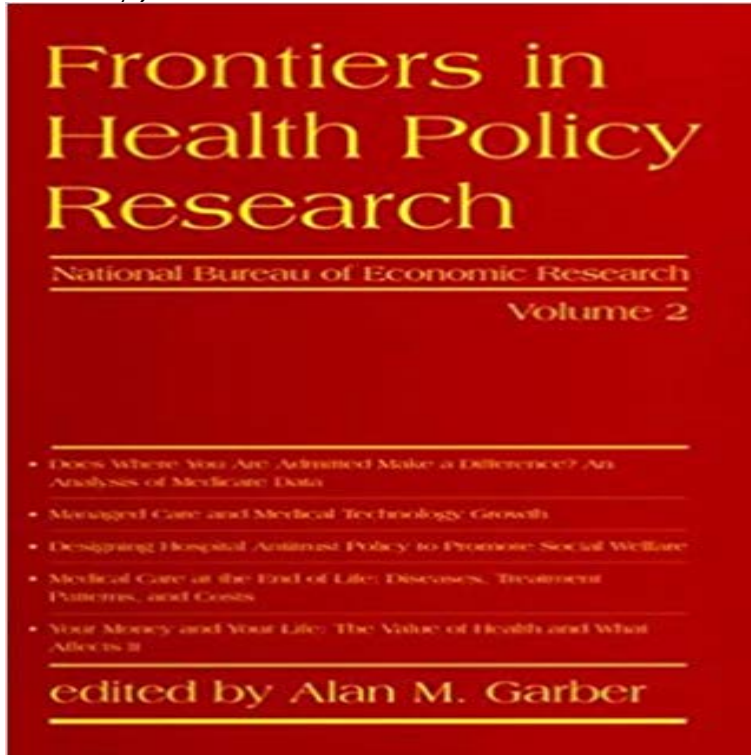


Frontiers in Health Policy Research, Vol. 2 (NBER Frontiers in Health Policy)
