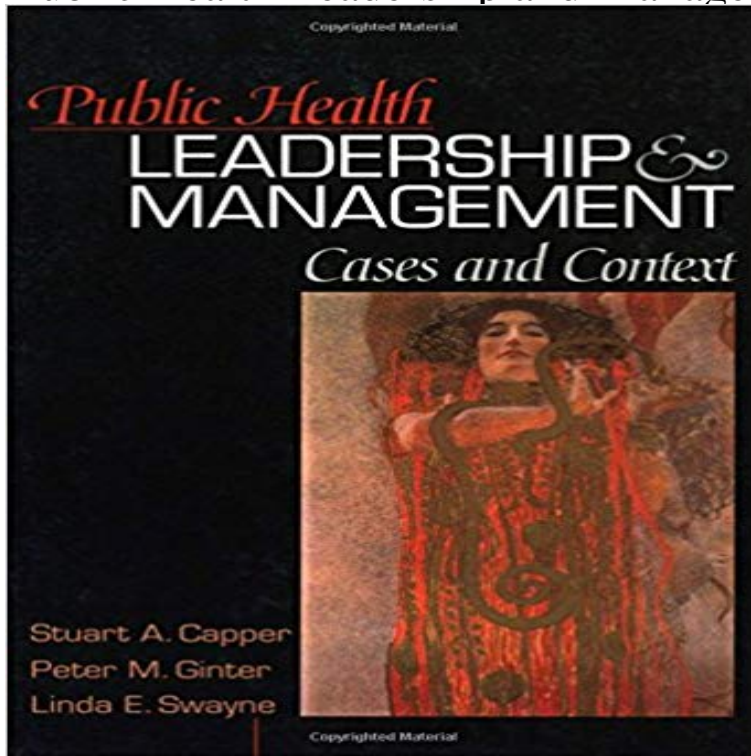


Public Health Leadership and Management: Cases and Context
