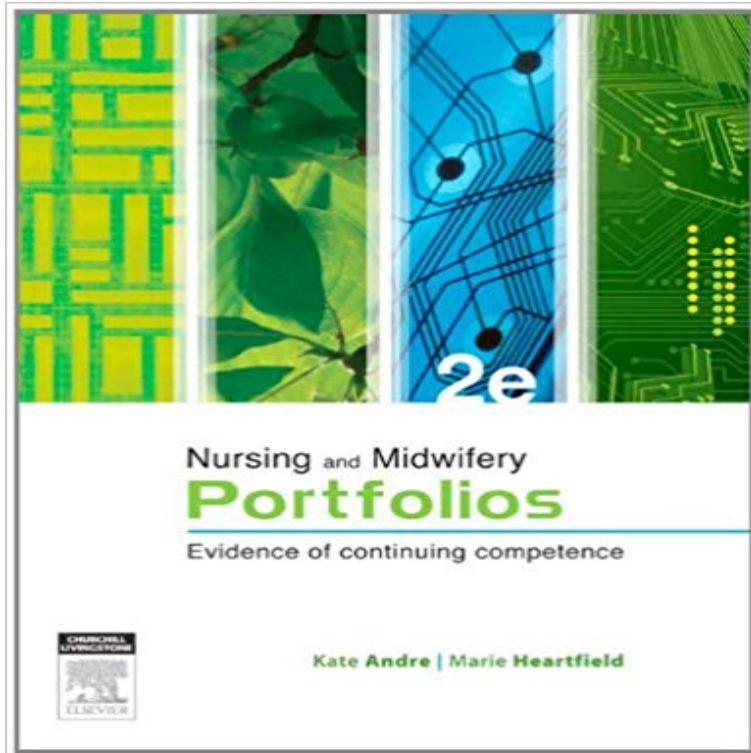


# Professional Portfolios: Evidence of Competency for nurses and midwives



The implementation of National registration requires Australian and New Zealand Nurses and Midwives to perform annual Continuing Professional Development.
