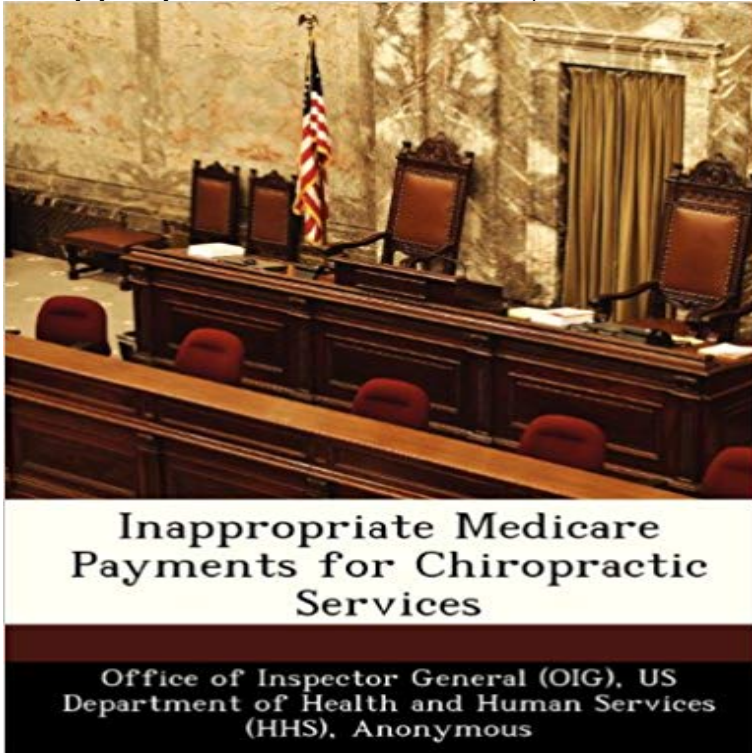


Inappropriate Medicare Payments for Chiropractic Services
