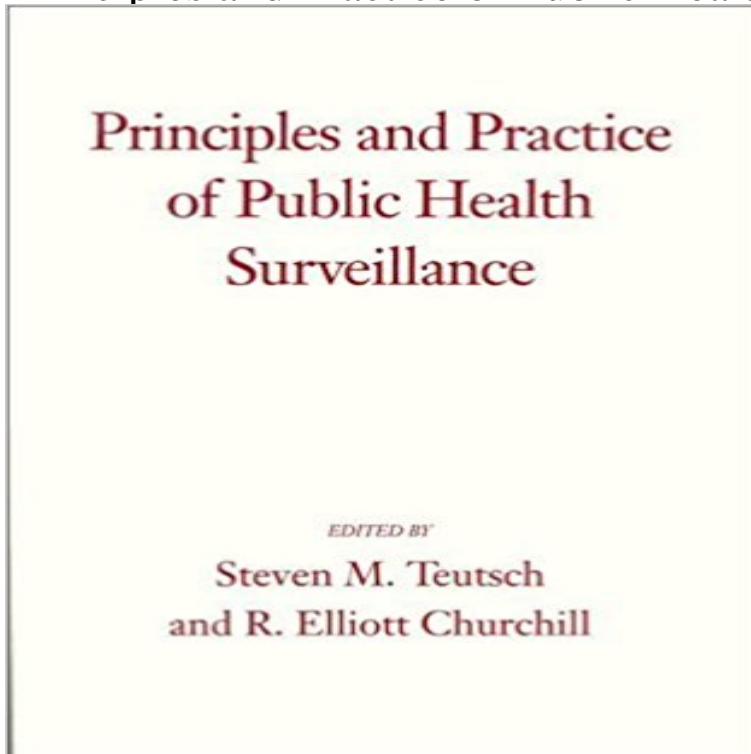


Principles and Practice of Public Health Surveillance
