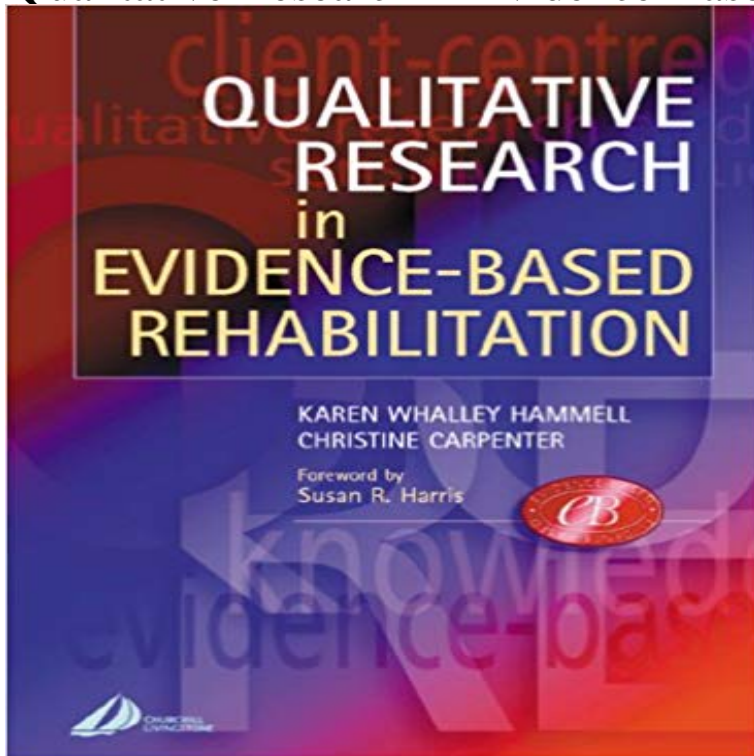


Qualitative Research in Evidence-Based Rehabilitation, 1e
